November 22, 1963, 12:15pm

O'Neal's Funeral Home attendants, Aubrey Rike and Dennis McGuire, in ambulance No. 606, transported part-time mailroom worker of The Dallas Morning News, 23 year old Jerry Belknap, to Parkland Hospital because the caller said Belknap was having an epileptic seizure, at 12:15pm in Dealey Plaza, by Houston and Main Streets (100 N. Houston St.). When Rike and McGuire arrived in Dealey Plaza, Belknap was lying on the sidewalk on the west side of Houston Street, directly across from the County Jail and Criminal Courts Building. He had a small abrasion on his forehead, faintly incoherent speech and exhibited some mental confusion; although Belknap did not display the usual signs of an epileptic: drooling, weakness or lack of coordination,

scuffed shoes or extremities, as a result of thrashing on the ground. They took Belknap to Parkland on a Code 3.

12:30pm (CST) - JFK was shot in Dealey Plaza

12:43pm - When Belknap arrived at Parkland Hospital he waited to sign in and suddenly men dressed in suites came running into the emergency room, yelling and wielding shotguns and machine guns - the scene had erupted into pandemonium. Secret Service men were hollering and swearing – demanding for someone to get them gurneys. John Connally was brought in first and he was bleeding badly, blood was pouring off the gurney, from his right arm onto the hospital corridor tiled floor. The group



of people with Connally began running down the hallway toward Emergency Major Medicine and placed Connally in Trauma Room 2. Ten seconds later, a second gurney came by with a man wearing a suite on it and his head was covered with a suite coat; SS agents Greer, Kellerman and Lawson were pushing the President on a stretcher and Jackie Kennedy, in her blood drenched pink suite, was holding onto the gurney as they ran down the hallway toward Emergency Medicine; Jackie was hanging on and running as fast as she could. President Kennedy was placed in Trauma Room 1.

Immediately after the gravely wounded President Kennedy and Governor Connally had arrived, at 12:43pm, the nurse of emergency admissions instructed Rike and McGuire to take their patient, Belknap, back through all of the confusion, to Emergency Major

Medicine and place him in Treatment Booth #8¹ on a hospital gurney, just around the corner from and sharing a common wall with Trauma Room 1; it seems they waited for JFK to be placed inside a room, before Belknap was placed, in order to ensure Belknap was reserving a treatment booth in close proximity to the President.

12:52 – Dr.'s Crenshaw, Jenkins and Baxter shut the President's eyes and covered him with a sheet. Baxter and Crenshaw walked out of Trauma Room 1 and Jackie Admiral Burkley (JFK's personal physician) were standing right there. Jackie sat down in a chair in the hallway and asked the funeral attendant Aubrey Rike, sitting opposite her on a gurney, for a cigarette.

12:55 – Dr. Crenshaw walked back into Trauma Room 1, there were several doctors and nurses in the room, including Dr. Fouad A. Bashour, Chair of Cardiology; he was Catholic and understood the significance of giving last rites.

12:57 – Dr. Crenshaw noted all of the President's clothes were neatly folded and placed at the end of the room (Crenshaw noted the time on his wristwatch)

1:00pm - President Kennedy was pronounced dead in Trauma Room 1 at Parkland Hospital, Dallas. Dead from severe gunshot wounds to the head, Dr. Malcolm Perry and his colleagues agreed – life extinct. In this paper we will detail what happened to JFK's body from that point onward.

Shortly after President Kennedy was declared dead in Trauma Room 1, Aubrey Rike made a phone call to his boss, Mr. O'Neal, at the Nurse's Station. Mr. O'Neal said he had already been notified about the casket and then Rike said he noticed Belknap was gone from treatment Booth #8. When he was interviewed by the FBI, on 6/11/64, Belknap said he left the hospital at 2pm; we believe that was more correct because that was approximately the same time the conspirators needed treatment booth #8 vacated to hide JFK's corpse there on a gurney.

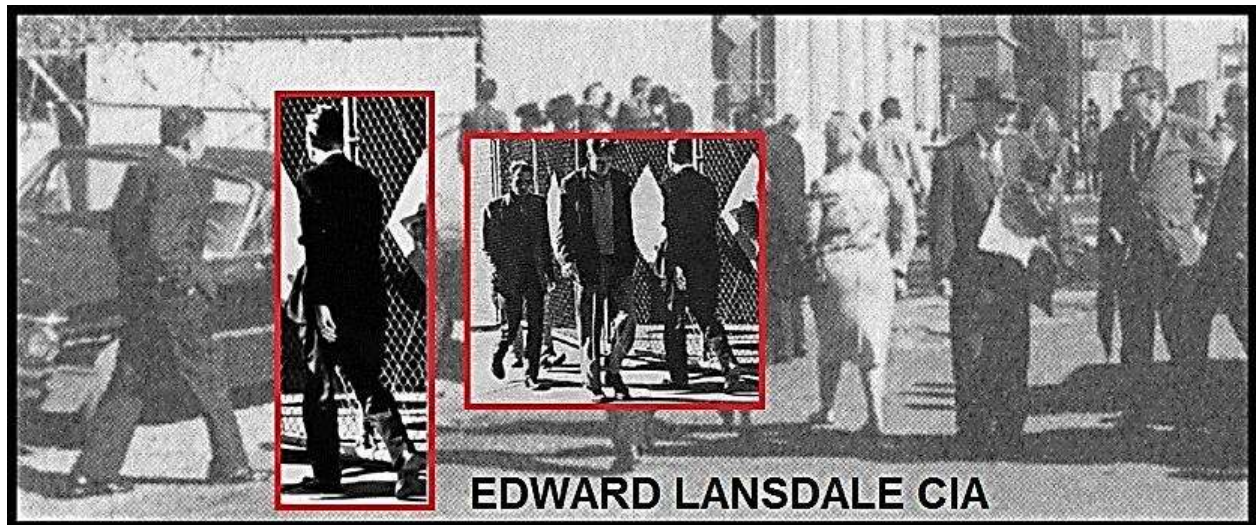
The timing was all too perfect...too perfect to be accidental, as Belknap's fake epileptic seizure in Dealey Plaza was surely a planned Deepstate distraction so the shooters could take their positions along the northern grassy knoll and in the buildings behind; which, of course, betrays Deepstate complicity and prior knowledge of Vernon O'Neal, Aubrey Rike and Dennis "Peanuts" McGuire, because O'Neal's two employees were involved in an obvious psychological ops distraction, that removed the ambulance away from the President, which JFK may well have needed and Rike and McGuire were already conveniently at Parkland Hospital prior to the Presidents arrival. And then, right

after the presidential entourage arrived, Rike and McGuire placed their phony epileptic patient in a reserved treatment booth near Trauma Room 1.

At 1:40pm, Vernon O'Neal delivered the President's bronze casket to Parkland himself – knowing his two employees to assist with the job were already in place - to help unload and deliver the casket, load JFK's body into the casket, shut the casket, reopen the casket, unload JFK from the casket, shut the casket again and roll it, EMPTY, all the way back out to the hearse... Surely Vernon O'Neal and his two employees were in the



know, and the prior distraction in Dealey Plaza, by the phony epileptic, Belknap, had the signature of Edward Lansdale² CIA written all over it; as Lansdale, was a master of psychological operations and the CIA Grounds Coordinator in Dealey Plaza that day.

The O'Neal Funeral Home, located at 3206 Oak Lawn Ave., in Dallas, halfway between Dealey plaza and Parkland Hospital, allows for easy access to both locations and, being Aubrey Rike and Peanuts McGuire were obviously placed at Parkland for a reason, we must ask ourselves - what was that reason?...To carry the casket? Surely the SS could've done that...To help Jackie put her ring on JFK's pinkie finger?...Get real!...To remove the man, Belknap, who had faked an epileptic seizure at 12:15pm in Dealey plaza, so JFK's shooters could take their positions? Yes, but, being that allowed Rike and McGuire to be at Parkland Hospital prior to the President's arrival, we have to conclude their convenient presence at Parkland was for some more significant contribution to the conspiracy - that was to occur at Parkland.

In a post assassination TV interview at the WFAA TV station, right next door to The Dallas Morning News, Aubrey Rike said, when all of the commotion of JFK's entourage arrived at Parkland Hospital he did not know what it was all about and then said, ***"it appeared to be some lunacy or something..."*** as if he was leaving a trail of evidence that he was not in the know ahead of time; this does not sound like the way Aubrey Rike would normally talk...and then he said they were told to wait around in case the president needed to be taken to another hospital...why would they have needed to do that? Parkland Hospital was a major trauma center with an emergency room staff very familiar with serious injuries...again, this sounds like Rike is documenting a reason for why he and McGuire waited around for over an hour to assist Mr. O'Neal, who delivered the casket, when, we are told, the decision to order a casket had not even yet been made...The post assassination TV interview of Rike and McGuire, in our opinion, appears to have been scripted by the conspirators to round out their official big lie about the assassination of the president.

And it is our contention that Aubrey Rike and Dennis McGuire, after Rike and McGuire lifted JFK into the bronze casket, closed the lid and, in the 10 minute interval when Rike and McGuire were with the casket³, along with the complicit Secret Service and CIA Jackie Kennedy, unloaded JFK back out of the casket onto the gurney and covered him with a sheet, then shut the casket and carried that EMPTY bronze casket back out to the hearse with the Secret Service, who drove the casket to Love Field airport and loaded it onto Air Force 1.

Trauma Room 1

We've forever been told that the bronze casket, supplied by O'Neal Funeral Home, was brought into Parkland Hospital, JFK was placed inside and, whilst wheeling the casket out of Trauma Room 1 and into the corridor, the Secret Service team of Clint Hill, Roy Kellerman and William Greer were accosted by Dr. Earl Rose (Parkland medical examiner/ coroner) and an almighty row erupted. Rightly, Dr. Earl Rose raised a huge objection at the body being removed. The crime had been committed in Texas and, under Texas law, that's where it should have remained. There was no federal offence of killing a president – Dr. Rose was quite correct. With guns drawn, angry words, swearing and high emotions, the Secret Service (my research suggests) battled for up to 30 minutes to remove the body, then drove the Empty bronze casket, in O'Neal's hearse, to Air Force One and flew it back to Washington DC. By every legal right, JFK's body should have remained in Texas, for his autopsy to be determined.

It was around 2pm, JFK had been declared dead for one hour and the suspect, Lee Harvey Oswald, had just been arrested at the Texas Theater, in Oak Cliff, at 1:50pm. Under those circumstances, any reasonable person would have thought the entourage and the widow of the deceased, First Lady Jackie Kennedy, would have done everything in her power to keep the chain of evidence clean and the law unbroken in order to secure the conviction of the killer... (And even if he was/is the chosen patsy surely that would have strengthened the case against him)...that is the normal progression of events. But here we see an entirely different set of reasoning, logic and resolution to the circumstances at hand – here is the point at which we must ask ourselves - why was this so?



Throughout JFK's treatment in Trauma Room 1, Jackie kept pretty much out of the way, sitting outside in the hallway, on a chair, smoking cigarettes with funeral attendants Aubrey Rike and Dennis McGuire, who sat opposite her on a gurney. The Secret Service had told Rike and McGuire to sit on a hospital gurney, in the hall opposite Jackie Kennedy. John Connally had been taken out of Trauma Room 2, almost immediately and upstairs to Surgery. Rike said no one came to comfort Jackie and she

never cried at all⁴. Rike noticed a two star general, standing eight to ten feet, off his immediate right, looking indifferent and he was carrying a medium sized, almost square shaped, hard shell, black leather briefcase in his left hand and the briefcase was attached to his left wrist with a set of handcuffs; Rike believed this was the legendary “football”; it was the man carrying the case with the nuclear codes to launch a major strike; which was pretty ridiculous considering the general was standing loyally near the president who had just had half his head blown off - if the United States had actually been attacked – there obviously was no one on hand to make any rational decisions at all.

The Secret Service, who we now know was complicit in the assassination; as they had pulled back their protection off the presidential limousine and had an in-car hit-team that shot President Kennedy in the left temple (SSA William Greer) and up through the left side of his head (CIA Jackie Kennedy) was guarding all of the doors to Emergency Medicine and would not let anyone in or out they did not want to pass.



In the hallway, a Secret Service agent would take the cigarettes from Aubrey, light them and then give them to Mrs. Kennedy; and the SS agent purchased a cup of coffee, tasted it and then instructed the pinstripe sales girl to pour a second cup for Mrs. Kennedy. Aubrey Rike says he helped Jackie remove the blood from her suite with a wet towel; although the author's do not believe that would've been possible as Jackie was described as having been covered with blood and we do not believe blood would've just wiped off that suite with a wet towel.

Once JFK had been pronounced dead, at 1pm, it was essential LBJ and his team got back to Love Field, before the world was told the sad news, by TV broadcaster Walter Cronkite at 1:38pm. Police Chief Jesse Curry drove LBJ to Love Field at 1:26pm, before JFK's bronze casket had even been delivered to Parkland, as LBJ surely knew the dead JFK and the entire presidential entourage was going to be heading back to Washington DC very soon.

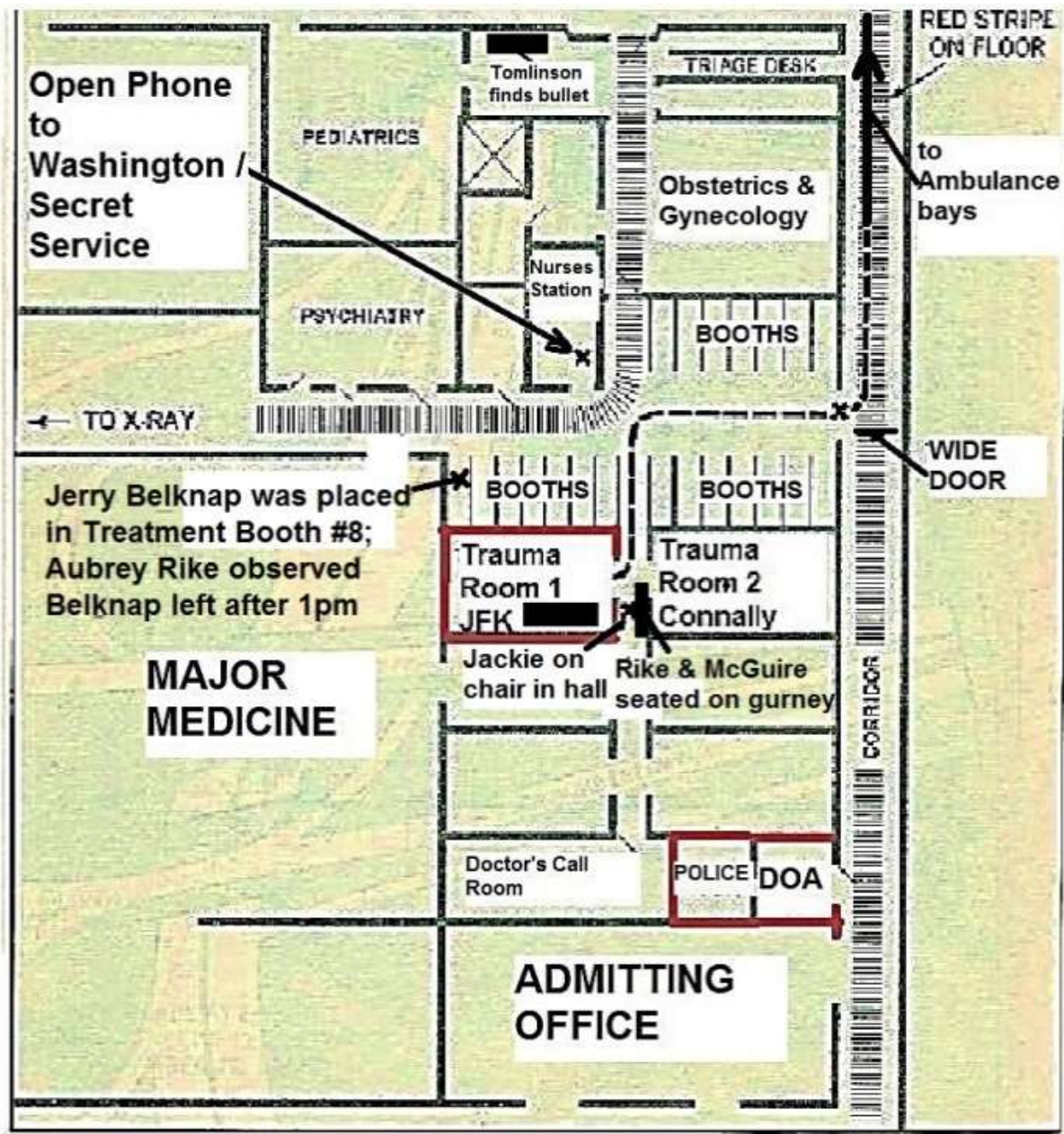
When a person is pronounced dead, of course, decisions must be made as to what happens next, this is the case and the questions loved ones must ask in all families.

The body must be removed from the place it was pronounced dead and released to the coroner or undertaker. It would have been at this point the very first discussions regarding JFK's remains occurred. It is completely outrageous to suggest anything other than somebody such as Clint Hill would have gone to the medical staff, the medical examiners room to ask *'what do we do next? Where do we get a casket from?'* ...Unless, of course, this aspect had already been pre-arranged.

After the president was declared dead, Aubrey Rike has stated, while he was sitting on a hospital gurney in the hall, a Secret Service agent came up to him and asked if he worked for a mortuary. Rike told him he did and the Secret Service agent said they were

going to need a casket to put the President in to take him back to Washington. Aubrey Rike called Mr. O'Neal, from the nursing station and Mr. O'Neal said someone had already notified him about the need for a casket and he was in the process of getting it all ready.

The O'Neal Funeral Home had a standing arrangement with Parkland Hospital, O'Neal's was their 'go to' funeral home, so it seems highly likely Hill (or whoever) asked about this first and made the arrangements for a nice hearse to come, the nicest of the fleet and the best, most expensive, bronze casket – both of which just happened to be available and arrived at the door of Parkland Hospital pretty much immediately, which leads me to strongly suspect Vernon O'Neal was primed in advance. It's been said Jackie immediately befriended funeral attendant Aubrey Rike – what was the First Lady of the United States doing befriending a lowly funeral attendant? And then Jackie was going back and forth speaking with members of her entourage and the Secret Service. It's our contention that Rike was Jackie's contact – as, immediately after the casket had been delivered (at 1:40pm), Jackie re-entered Trauma Room 1 and Aubrey Rike made sure Jackie got her wedding ring on JFK's little finger – so he could readily be identified from his body double, JD Tippit. And, more than likely, Rike got in sync with Jackie concerning JFK's removal, during the distraction argument, between Dr. Rose and the Secret Service, from his Bronze casket...

In addition, in later years the bloodied shirt of funeral attendant, Aubrey Rike, who helped remove JFK that day, has been placed in a transparent case, mounted on the wall of the O'Neal Funeral Home, on display for public viewing. Aubrey Rike has said he lifted JFK's head and Dennis McGuire had his feet. Rike said, ***"I pulled it all the way out. I was at the head and Peanuts (McGuire) was at the foot."*** Aubrey Rike's shirt was stained by the blood from JFK's head that was seeping through the sheets JFK was wrapped in; Aubrey Rike said he could feel the sharp edges of JFK's large right rear head wound through the sheets.

We can see from this scenario, the decision to order a casket and remove the body to Love Field, in the minutes after 1pm, had already been made in advance. Surely the staff, not just Dr. Earl Rose, would have been very aware about the removal of bodies and the need for an autopsy, under Texas law. The time for this conversation, about how the Secret Service "cannot do this" (steal away JFK's body without an autopsy) should have and would have been noted at THE POINT THE CASKET WAS ORDERED.

This leads me to conclude the heated debate; the Secret Service had out in the corridor with Dr. Earl Rose, from approx. 1:30 – 2pm and, up to the time **the casket was being removed**, just after 2pm, was a STAGED EVENT. We will now work through the details in order to see why this was so.

1:01pm – with the exception of his feet, which were exposed, the President's body was covered with a sheet. Jackie and Admiral Burkley entered Trauma Room 1; Jackie went to the end of the gurney, leaned over and kissed his big toe. **The priest, Father Huber**, stepped to the head of the cart and carefully uncovered the President's head as not to display the wounds, *"John Fitzgerald Kennedy, if you are living, I absolve you from your sins in the name of the Father, the Son and the Holy Spirit."* Father Huber dipped his thumb in holy oil and traced a cross on the President's forehead. When the priest concluded Jackie left the room. Most of us followed except for several nurses. Dr. Crenshaw, "I looked at my wrist-watch; it was 1:01pm."⁵

1:06 – JD Tippit was shot to death in Oak Cliff by Gary Marlow (CIA; 3 shots to the body) and Roscoe White (CIA; 1 shot to the right temple)

1:10 – Dr.'s Crenshaw, Baxter, Jenkins and Clark, congregated at the nurse's station, decided to put **1:00pm as the time of death on the death certificate although it was 1:10** and the last rites had been given prior to that.

Dr. Crenshaw opened the door to Trauma Room 1, to check on the progress of the nurses who were preparing the President's body to be moved and Crenshaw turned around as he **heard an argument erupting between Vernon Stewart and Dr. Sidney Stewart (pathologists) with the Secret Service** – the President's aides and the SS were arguing to take JFK's body to Washington for autopsy but the doctors were forcefully explaining that, under Texas Law, they had to perform the autopsy before the body left Parkland Hospital. It was **1:10pm**.



Dr. Crenshaw, "There was a time frame of an hour and a quarter from the time he died to the time he was removed at a few minutes after two."⁶



After the president had been given his last rites, by Father Huber, at 1pm and Aubrey Rike had returned from making his phone call to Mr. O'Neal at the nurses' station, a Secret Service agent told the funeral attendants, Rike and McGuire, to go into Trauma Room 1 and prepare the president's body – they wanted them to clean his remains and prepare him for placement into the casket; no doubt they had in mind utilizing the

strength of Rike and McGuire to lift JFK onto a clean gurney, with a rubber mat and sheets already in place in order to wrap the president for his journey back east.

The president's discarded clothing was lying in the corner of the room and the president was lying on the emergency treatment table and was completely covered with a clean white sheet. Rike pulled back the sheet to see the president's head had been wrapped with a sheet, several times around, overlapping itself and he could not see the president's head or face at all. The only people present at the time were Nurse Doris Nelson, Rike and McGuire. They turned the president over onto his side, with his front facing them, so they could determine if he had any blood on his back that would need to be removed; they noticed that fluids had already begun to settle into the tissues of his back as a result of gravity, resulting in splotches of black, blue, and even purple where the blood had pooled in livor mortis. They were trying to determine what steps were needed to be taken to clean the body for placement into the casket.

It is the author's contention that, at that point, Rike and McGuire lifted JFK up from his initial treatment gurney and placed him onto another gurney that had a large rubber sheet on it and other sheets to wrap him in. JFK's initial gurney was then pushed out of the room; possibly the gurney Rike and McGuire had initially been instructed, by the Secret Service, to sit on outside in the hallway was used for this purpose.

Rike and McGuire wrapped or enshrouded the president in a clean white hospital sheet. Out in hallway, the confrontation over removing the casket from Dallas now began. That confrontation, we now know, was a DISTRACTION TECHNIQUE / STAGED EVENT to facilitate and conceal the removal of JFK from his Bronze casket.

1:25 – as the argument was raging outside Trauma Room 1, across the corridor by the nurse's station **since 1:10**, Judge Theron Ward arrived and was immediately confronted by Dr. Earl Rose (the coroner), with his right hand raised and finger pointed to the ceiling, Dr. Rose exclaimed, "Ward you're out of line!" Referring to the time in which the autopsy could have been made, Rose said, "We can have him out of here in 45 minutes!" It was Dr. Rose's duty to examine the President's body, his clothes and the crime scene.

The Bronze Casket – Jackie's Wedding Ring

1:40 – funeral home owner, Vernon O'Neal, arrived at Parkland Hospital with the bronze casket in his best Cadillac hearse. The presidential limousine was driven out of the ambulance bays to make room for the hearse. O'Neal's staff, Aubrey Rike and Dennis McGuire, conveniently on hand, wheeled their most expensive, heavy, bronze casket (on a folding mechanical dolly) into Parkland Hospital down the wide corridor to

Trauma Room 1. Dr. Crenshaw opened the door and allowed them to enter. They placed the casket alongside the president's gurney and opened the lid so they could pick him up and transfer him into the casket. The President had been cleaned and wrapped in 2 white sheets.

At that point, Jackie Kennedy came in with a Secret Service agent and Nurse Doris Nelson. Aubrey stood behind the president's head, in the interior of the room, Peanuts McGuire, Nurse Nelson and Jackie were by his feet and the Secret Service agent lingered near the door.



After a few moments Jackie pulled back the sheet and removed her wedding band - Jackie was trying to place her gold wedding ring on JFK's finger; as JFK was a man with bigger fingers, she struggled to put her wedding band on JFK's finger. Aubrey Rike helped Jackie find some K-y jelly and slide the ring onto JFK's little finger, of his left hand.

Let's think about this scenario...The body was going for autopsy, to the morgue, to the funeral parlor – all of the places where wedding rings of First Lady's would very likely be stolen...it makes absolutely no sense at all for her to have taken that risk, yet here we see Jackie Kennedy doing exactly that...And there was a very good reason she did that which we will come to later. It was time to leave and it had been pre-determined the casket would be going back to Washington DC and Bethesda Naval Hospital where the Deepstate conspirators had complete control of the autopsy.

***Author's Note:** Aubrey Rike has told the story that he placed Jackie's wedding ring next to JFK's wedding ring. We know that cannot be true because the photo record reveals JFK never wore a wedding ring. Possibly, Rike embellished his story to add logic to Jackie's having put her wedding ring onto JFK's hand, which makes no sense at all – that is until you come to the realization that Jackie was a conspirator and she was doing that so JFK could readily be identified from his body double JD Tippit.

1:45 – Aubrey Rike states⁷, (in his book, *At the Door of Memory*, 2008, p.58), the first time he began to pick up the President, off of the gurney, he put his hand under the President's head and he could feel the serrated edges of the blasted out hole, in the right rear of the President's head through the sheets. Then, as he put his hand further under JFK's neck to lift him, his hand and the cuff and forearm of the right sleeve of Rike's shirt became covered with blood and they replaced the President onto the gurney and he asked Nurse Doris Nelson if she could get a rubberized sheet to put inside the casket. He wanted to roll up the edges to make a dam in the casket interior so the blood would not wick down into the lining and stain it.

Then it was said the president had not had his last rites so they waited, before lifting the president into the casket, for Father Huber to come to Trauma Room 1 a second time (Father Huber had already give the president his last rites at 1pm); Father Huber was conducting a TV interview outside and had to be tracked down. Mrs. Kennedy left the room, but Rike and McGuire were instructed to remain in Trauma Room 1 and waited for what seemed like an eternity before the two priests entered the room, introduced as Father Huber and Father Thompson, along with Mrs. Kennedy.

1:55 - The priests administered the Final Sacrament for the second time, as Father Huber placed a purple colored stole around his own neck before approaching the president. Father Huber pulled back a small part of the sheet, revealing a small portion of the forehead and anointed the President's head with Holy oil and prayed in Latin, then replaced the sheet and continued in English. Father Huber blessed the body and sprinkled the interior of the adjacent casket with holy water and nodded at Aubrey Rike, indicating he had finished the Final Sacrament.

Rike and McGuire then lifted the president into the casket, closed the lid and the priest placed a crucifix on the top of the casket. The priest stepped to the doorway where Mrs. Kennedy thanked them for their prayers and kind words. The Secret Service began to withdraw from the room and that was the time for Jackie to spend with her dead husband.

Parkland Nurse Diana Bowron (WC Testimony), *“Mrs. Kennedy wanted to be alone with him after the priest left, so we all came out and sat there outside and she was alone with him in Trauma Room 1, and we didn’t go in any more after that.”*



The Bronze Casket – Jackie’s Change of Clothing

1:58 - Father Huber stayed with Jackie and then allowed her to have a few minutes alone with JFK. At that point, we believe, Jackie changed into a second pink Chanel suit, that was almost identical.

The Pink Chanel Suit

There have been questions for a long time about Jackie’s pink Chanel suit. It’s clear to see, in comparisons of photos of Jackie that day, Jackie descending the steps off Air Force 1 that morning – her jacket fit very snugly, then later that afternoon, as Jackie stood next to LBJ on AF1 for the swearing in – her jacket appears to be hanging off her arms. Whilst we can say traumatic events can cause people to lose weight, it does not happen in the space of 3 hours. We have analyzed the photos of Jackie arriving at Andrews Air Force Base, in Washington DC early that evening and it’s very apparent there simply was not enough blood on her skirt and jacket for someone who had held her husband’s blasted out head on her lap (as we’ve been told). The picture of the back

seat in the limousine at Parkland Hospital suggests so much blood that the skirt front & back should have been saturated. We simply do not see that on the pictures of Jackie after she left Parkland Hospital.

So the question we must ask is: why would Jackie change her suit? The answer is twofold. Having been so close to JFK in the car, Jackie's suit would have picked up traces of the shellfish toxin poison dart fired by the driver, Secret Service agent William Greer's specially adapted pistol. Greer shot JFK immediately after he stopped the car, just before the triple underpass - turned, pointed and shot. There is no way Greer could have continued driving while he turned, aimed and shot JFK at the same time - so, to shoot JFK, is obviously the only reason Greer stopped that car, for some 8 - 10 seconds, on Elm Street.

"Imagine that final second, Greer stopped the car and shot silently (312), Jackie shot like a firecracker (313), James Files shot - BOOM!!(314) and then Roscoe White shot (315) and that was it." - JFK assassination Researcher Richard M. Hooke

The second reason Jackie changed her suit is she shot JFK herself, up through the left side of his head, using both their bodies as a shield and the lambchop hand puppet to shoot through, so no one would ever see the gun. Of course the nitrates and blood spatter are all evidence and, if the Dallas police had been doing their job correctly, Jackie would have been taken in for questioning and her suit for analysis that very afternoon. Of course, there was no way the conspirators could allow any of that to happen, so Jackie changed her suit in Trauma Room 1. If we look at the blood on her nylon stockings it was obviously much higher in concentration than that which appears to be hand smears across her suit - as depicted by photos taken at Andrews AFB.

At approx. 1:58pm, Jackie used those last minutes with her husband to dupe and deceive the American people. She simply smeared a little blood onto the new suit, from her initial blood soaked suite and saturated gloves, to ensure she had some blood on the replacement suit and later could say she did not change in order to, *"Let them see what they've done,"* in a classic Illuminati limited hangout ploy - to deflect suspicion away from the fact she had disposed of her initial incriminating suite.

Jackie's blood drenched gloves, hat, nylon stockings, lambchop puppet and blood spill bucket and all of the sheets from Trauma Room 1 have never been recovered - they are missing...The first suit destroyed, the suit she wore from then on (if that had been taken as evidence would have been found free of nitrates and fish poison) was taken by her mother, Janet Auchincloss and placed in a sealed box - it is owned by the Kennedy family (strange in itself that the family is allowed to own evidence in an officially unresolved crime); it will be in the national archives, not available for public viewing, until 2103. When Jackie's second suit is examined, in 2103 and no traces are found,

they will declare we were wrong but, of course, the real suit, with toxin poison, is already long gone – probably burned.

Parkland Nurse Phyllis Hall (YouTube video), said she left Trauma Room 1, after JFK was pronounced dead, yet before the priest, Oscar Huber got there at 1:01pm (the first time) – so nurse Hall had to have seen Jackie before she changed her suit and nurse Phyllis Hall said there was a large fist sized hole in the right rear of JFK's head and it seemed like nearly all of the missing brain tissue and blood was all over Jackie Kennedy. Nurse Hall simply cannot be describing the clean suit Jackie was wearing on AF2, during LBJ's swearing in.

1:58 - It is the author's contention, when Jackie was alone with JFK's casket; she changed her clothes, into a second pink suite and then hid her initial bloody suite under JFK's bloody clothes which were piled in the corner of the room. Aubrey Rike states⁸ that, at about the time they were preparing to exit Trauma Room 1 with the casket, a nurse, possibly Doris Nelson, entered the room and was carrying a brown Safeway Grocery paper sack. She picked up the president's clothing, from the trauma room floor and placed it in the sack. When you think about it, it makes sense Jackie changed right before she left because there was practically no time for anyone to recognize she had done so, other than the complicit Secret Service agents, as they all hustled the EMPTY bronze casket back out to the hearse.

Dr. Earl Rose's Limited Hangout Distraction

2:03pm - Aubrey Rike states that, after the President was casketed, he was back inside Trauma Room 1 and they tried to move the Bronze casket forward out of the room but were halted by the Dallas County people who pushed the casket back into the room and this went back and forth many times...this went on for what seemed like about 10 minutes to Aubrey Rike⁹.

Judge Theron Ward was led to the door of Trauma Room 1 by SSA Kellerman. Kellerman requested Ward to release the body into SS custody. Theron Ward was 39 years old with a ninth grade education, from Garland, TX, a Navy WWII veteran who had been shot 9 times and carried a steel plate in his head. Following the war he had served 5 years as Deputy Sheriff and 5 years with the Dallas police. Judge Ward had only recently been elected Justice of the Peace and had minimal legal background.

Everyone's attention was distracted by the struggle between the Secret Service and the Dallas doctors, while the casket remained in Trauma Room 1...The body, no doubt, was lifted out of the bronze casket and hidden under a sheet...

Dr. Earl Rose was there and said, "You're not going anywhere with him!" The SS agent said, "Let's go!" And they started again and then the struggle really began. The local authorities pushed them back into Trauma Room 1...They tried vainly to move the casket out again into the corridor and the local Dallas County people pushed it back into the room – and this went on for what seemed like ten minutes.

JFK'S CORPSE – STOLEN BY THE SATANIC ILLUMINATI GHOULS

It's our contention that during this juncture, when the casket was pushed back into the room, the SS agent guarding the door told Rike and McGuire, "Alright were getting that body out of here one way or another. Put him back on the gurney – we're gonna take him back east in a different box; and you'd better not EVER mention it to anyone – or you're dead." And Rike and McGuire unloaded JFK and laid him back on the gurney under a sheet. What else could they do? Remember, Jackie Kennedy and the Secret Service were complicit and Father Huber was an old friend of Jackie's Jesuit Illuminati Catholic family and had been selected by Jackie to be at Parkland; so they all, no doubt were in the know, conspirators and unloaded JFK's corpse, right there in Trauma Room 1, while the SS agent guarded the door.

Jackie Kennedy was standing at the back of the casket and Father Huber was trying to walk alongside the juggling casket – as he was blessing with Holy water and chanting in Latin, seemingly oblivious to the ongoing struggle. The crucifix he had put on top of the casket, which was held by a magnet, was being jerked around so much in the tug-a-war that it was sliding off and they had to stop twice because they had to prevent the casket from falling off the funeral truck onto the floor (possibly the casket would have been more stable if it had actually contained a body!).

Aubrey and Peanuts stepped forward and a few steps back, repeatedly – like an obscene dance. There was a wild mob scene – people shoving and swearing,

“It was your mother fucking fault!”

“The son-of-a-bitch was supposed to be doing this!”

“Fuck this,” and “Fuck that!”

Finally, they made their way down the corridor, inching forward a few feet at a time... They had made it about 30 feet and someone said, “Let the son-of-a-bitch go!” As Judge Theron Ward had said he’d sign the death certificate and everyone reluctantly backed off and then they moved quickly out with the casket toward the hearse.

Aubrey and Peanuts loaded the casket, 3 SS agents rode in the front seat, CIA hit-lady Jackie Kennedy rode shot-gun beside the casket, 3 more SS thugs piled into the rear and the Secret Service Freemason assassin William Greer was at the wheel.

Once they were down the hallway, the president, under a sheet, was wheeled on the gurney into treatment booth #8 and then, once the coast was clear, back to the DOA room.

Father Huber blessed and absolved the president twice that day and ensured President Kennedy’s soul ascended into Heaven but, I am sorry to say, his corpse was lost, stolen away by the satanic Zionist Illuminati ghouls; in a bizarre Statue of Liberty play, the evil of which the world has rarely seen, as the 6’5” SS thug, Roy Kellerman, like Harrison Ford, in Star Wars, gone mad – over to the Dark Side, led the flying wedge of deception with a scowl and gun drawn leading the SS charge, of thick wristed, square jawed and jar headed Freemason thugs with the EMPTY bronze casket, while JFK was hidden in treatment booth #8, on the gurney of the fake epileptic, wheeled back to the DOA (dead on arrival) room, as designed by Rubenstein and stuffed in an unmarked and unlined box with his body double, Dallas policeman Jefferson Davis Tippit, by the CIA mortician Liggett, loaded on AF2 and worked on in a ghoulish way by CIA David W. Ferrie’s (Ferrie was an ex Jesuit priest – defrocked for child molestation) Civil Air Patrol buddy,

John Melvin Liggett, on LBJ's vacated VP bedroom mattress...surely in the bowels of the ghoul's from hell.

A Body Double was Necessary

Dallas policeman JD Tippit was murdered by the CIA, in the Dallas suburb of Oak Cliff, at 10th & Patton, at 1:06pm, that same afternoon and Tippit was first taken to Methodist Hospital in Oak Cliff, the conspirators had their body double secured. We know that Lee Oswald did not shoot Tippit and that Tippit was murdered by the CIA, in a pre-meditated murder for Tippit's corpse – to be used as the body double for JFK.

The conspirators knew they would have to present evidence, an autopsy report for President Kennedy. The preset narrative was always going to be one shooter, from behind (Oswald in the sniper's nest) but they also knew JFK was going to be shot from multiple directions from the right front of the car (grassy knoll), from directly in front by the SS driver of the car and at close range, POINT BLANK, UP THROUGH THE LEFT SIDE OF HIS HEAD – BY HIS OWN WIFE JACKIE KENNEDY. This of course needed to be completely covered up, hidden from view but, at the same time they knew there was an absolute need to present some sort of written photographic record. That was why JFK's body had to be completely under control, the autopsy could never be allowed in Dallas and had to be done in a military hospital (Bethesda), where the military conspirators were controlling the whole Deepstate side show.

Methodist Hospital functioned as the holding area for JFK's backup corpse, before it was quickly summoned to Parkland Hospital, no doubt by a phone call from CIA/MOSSAD asset/ Mafia associate/ conspirator Jack Rubenstein. The official line is that Tippit was taken to Parkland for his autopsy...What? Wait a second, did they not have anyone qualified to do post mortem work at Methodist? And even so, that being the case, Tippit was transferred very quickly – he sure queue jumped everyone else who died that day or the day before at Methodist with no coroner in service. I do not believe that for one second. In fact the testimony of Lottie Thompson, ER nurse, suggests that an autopsy had already begun on Tippit at Methodist and the bullets were already removed from his body at Methodist prior to Tippit's corpse having then been driven to Parkland by the Dudley Hughes Funeral Home where Dr. Earl Rose testified and produced an autopsy form for Tippit stating Tippit was autopsied at Parkland, by himself with no witnesses, between 3:15 – 7pm. That entire highly questionable and nefarious scenario, the highly illegal break in the chain of evidence makes no sense at all – especially when we consider Lee Harvey Oswald was arrested and brought in on the basis of killing Tippit (not JFK) at 1:50pm. It was a complete debacle, a shenanigan to obfuscate, cover up and keep the plan on track to allow the perpetrators to remain free. There is simply no other reason...

Once a dead body arrives at a hospital guess where it goes...yep, the DOA room. This was where the corpses of JD Tippit and JFK were first together – the DOA room of Parkland Memorial Hospital, Dallas.

JD Tippit's body arrived at Parkland through the back door around 2:15pm and then EMPTY bronze casket left Parkland through the front door around 2:20pm. According to our time deduction and the testimony of Parkland staff member JC Price, who looked up and noticed the time the bronze casket was removed (2:20pm), this clearly indicates the confrontation out in the corridor was a staged event and served two purposes: as the press and large crowd gathered was focused on the front entrance, allowing safe access to the back door – no one was watching what was going on around the back of Parkland, while the EMPTY bronze casket was driven to AF1 by the SS, in O'Neal's hearse, at 2:25, JFK & Tippit were then driven to AF2 by the CIA, in Liggett's van, squashed in an unmarked box, at approx. 2:30.



2:00 – CIA embalmer / reconstruction expert, **John Liggett** spoke with his wife on the telephone from Parkland Hospital

2:15 – JD Tippit was admitted to the Parkland Hospital DOA room

2:20 – JFK's EMPTY Bronze casket left Parkland Hospital; employee **J.C. Price (exhibit 33)** said, "At the time the casket (JFK's Empty Bronze casket) passed the cashiers office, I looked at my watch and the time was 2:20 pm. I watched the hearse leave, then went back into the blood bank."

2:38 – LBJ was sworn in as the new President aboard AF1 at Love Field.

2:47 – AF1 left Love Field, Angel (code name for JFK) was airborne and AF2 departed shortly thereafter.

Jack Ruby was at Parkland Hospital

We have to remember that **around 1pm Jack Ruby was seen at Parkland Hospital**. It is my opinion he was fully involved in working this switch. The likelihood is that Ruby had recruited in several people; possibly even police officers (Ruby knew 2/3 of the Dallas police force) dressed as medics or orderlies, or even as themselves, to lift JFK's body back out of the bronze casket. Ruby was not present at the time of the

confrontation as we know he was in the back of the Texas Theater, during Oswald's arrest at 1:50pm. But Ruby had been at Parkland earlier, as witnessed and testified by Seth Kantor who said he spoke to Ruby about 1:30pm. Mrs. Wilma Tice¹⁰ also said she spoke with Ruby at Parkland. Radio newsman Roy Stamps, who had met Ruby on about 45 occasions, prior to 11/22/63, also said he was in the hallway at Parkland when he noticed Jack Ruby enter – Ruby was carrying some television equipment and trailing behind a TV crew.

I strongly feel Ruby was ensuring people were in place, making decisions in the moment as to what was required. Ruby no doubt heard details of Kennedy's head wounds and, whilst at Parkland, placed a call to an associate at Methodist Hospital to say that yes the body of JD Tippit was required; Tippit may still have been alive at that point – shot at 1:06pm but the plan, orchestrated by Ruby, with personnel recruited by Ruby, was ready to go. It's also very possible Jack Ruby called, through the police switchboard (dispatch) to the police car that was parked in the driveway at 10th & Patton (not Tippit's) and called for the hit to be put on JD Tippit.

Tippit & JFK – Packed into a box in the DOA at Parkland

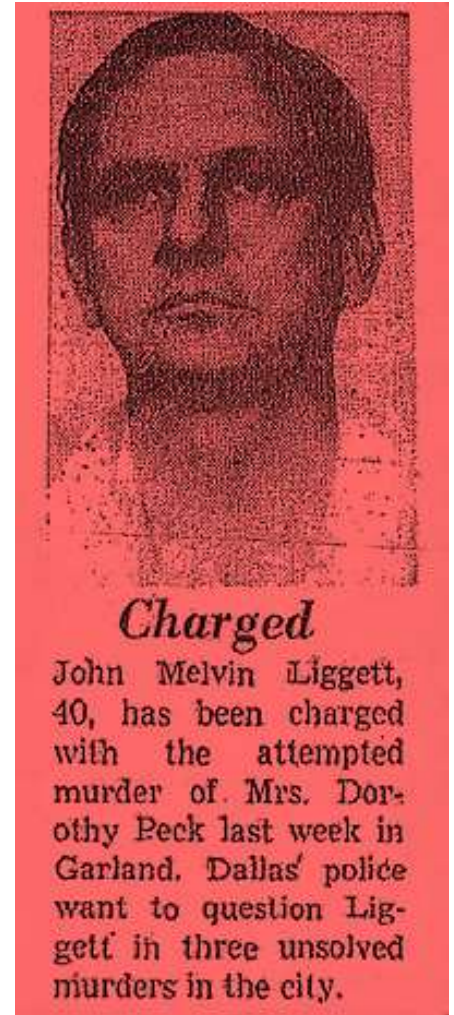
Until now it has been assumed, by those of us who realize there was a body switch, that the cadaver of JFK was removed from the bronze casket, once it was onboard AF1- during LBJ's swearing in and then reloaded onto AF2. I feel, from my research that is not the case. When you think about it, removing a body wrapped in a sheet, from one plane to another, is a very risky business. For a start, there were far too many unassociated people, airport workers, press and a gathered crowd to look at the presidential planes. Even though all the film footage was done with long lenses and the media was instructed to keep well back, I just cannot logically picture JFK's body would have been switched that way – very messy, grotesque and physically difficult indeed. Instead, both corpses more than likely were in the DOA room back at Parkland. The conspirators brought both bodies together at Parkland to leave Parkland together – there is no other logical reason – otherwise JD Tippit could've just been transported to Love Field from Methodist Hospital, in Oak Cliff, where Tippit's corpse had been held in that staging area...waiting for ***the call from Jack Rubenstein that the body-switch was on.*** Time was of the essence – it was really important those bodies were in that Parkland DOA room for the shortest amount of time...I suggest 10 minutes maximum...then into that room arrived **a friend of Jack Rubenstein, who also was an old friend of David W. Ferrie (CIA), from the Civil Air Patrol by the name of John Melvin Liggett.** The fact that Liggett was even summoned to Parkland at all tells us that it was to transport JD Tippit & JFK to AF2.

John Melvin Liggett

Liggett was employed by the Rest Land Funeral Home in Dallas that was owned by his brother, Malcolm Liggett who was a CIA asset and a friend of Jack Rubenstein. John Liggett was known to be the absolute best embalmer / mortician / reconstructive surgeon on the planet and his skills had often been utilized by the CIA. He was summoned to Parkland while he was working another funeral; although, I believe for sure he was tasked ahead of time, they knew where to find him!!! How do you contact someone at a funeral in 1963 without a mobile phone? How easy and unsuspecting it must have been for this mortician to jump into his van or hearse with a casket already in it. Nobody would've questioned this mortician, who worked at the Rest Land Funeral Home, when he drove up to the back door of Parkland Hospital and unloaded a casket...no one would've thought anything of it at all. All of the action and focus had been on the front door (ambulance bays) of Parkland anyhow. How easy it must have been for Liggett to unload his cheap shipping casket and bring it inside.

On 11/22/63 CIA Asset **John Melvin Liggett** was with his wife Lois at Restland (Cemetery in Dallas) attending the funeral service of her late aunt. He suddenly was called from the gravesite. Lois Liggett, "John went to the office and came back very shortly and explained to me that the President of the United States had been shot. And that he was called to go to Parkland Hospital. I went home after the funeral and it was about 2pm in the afternoon and John called me from Parkland. I could hear confusion in the background and I asked him what was going on...he said the President has died. And I said well did Restland get the job? And he said no – some other funeral home got the job but he said, ***'I've got a lot of work to do. Don't try to call me, I'll call you as soon as I can.'*** And it was about 24 hours before I heard from him again."



If we look at the position of the DOA room at Parkland we see that it had a door through to the police room...easy to see how Jack Ruby could have recruited maybe 3 police officers there to assist – both guarding the room and lifting the bodies. With Liggett's help the correct bodies were identified. Someone had written 'Tippit' on JD Tippit's left arm (Dr. Rose said was a 'tattoo' on his autopsy report) and JFK was identified by his left hand – as Jackie had placed her wedding ring on JFK's left pinkie finger. That was

precisely why Jackie placed her ring on his finger. In that one act, we can be certain Jackie knew about the entire plot to use JD Tippit as a body double; of course she was in the know – and the reason was to cover up her murder of JFK, make no mistake about it - JACKIE SHOT JFK and the reason for Tippit's death was to cover that up), to ensure that, if there was another body in the DOA room, besides JD Tippit and JFK, the correct corpses could be identified.

***Author's Note (R. Hooke):** “And do you really think that the First Lady, Jackie Kennedy, who was known to have been all about money, would've willingly sent her wedding ring to the morgue...if that was not part of the plot? And this act by Jackie also gives us great insight into Jackie's true nature –

“Anyone who would sacrifice their wedding ring, so her dead husband could be identified from his body double / swapped corpse at his falsified autopsy, so that she could get away with his murder is one cold blooded Illuminati / CIA satanic witch for sure! JFK had been removed from the bronze casket, by O'Neals attendants Rike and McGuire, during the distraction argument by Dr. Earl Rose, when JFK was hided on a stretcher, behind a sheet in a treatment booth and, after the EMPTY bronze casket left Parkland, JFK (under a sheet) was pushed on the gurney down to the DOA room and stuffed into a non-descript shipping casket, with his body double JD Tippit and then driven to Love Field and loaded onto AF2, by CIA asset / mortician / reconstruction expert John Melvin Liggett.

Disgusting and unceremonious as it was, both bodies, JFK wrapped in sheets and Tippit in a body bag, were surely placed head to toe, squashed in, together in a cheap plain shipping casket with no lining. BOTH BODIES, IN THE SAME CASKET, were driven to Love Field, by Liggett and boarded onto AF2.

“The president's body did not go back on Air Force 1. According to the Captain in charge, of the Dallas police, told me the president's body went back on the support plane and not the plane with LBJ and Jackie and so forth; the casket on that plane was not with the president's body.” – CIA agent James Huggins¹¹

The Limousine Hit-Team – Guardians of the EMPTY casket


An important point to note here is that the bronze casket was loaded into the hearse and driven to Love Field by the Secret Service (SS agent William Greer). From that

point onward, the EMPTY bronze casket was overseen all of the time by the “in car hit team”. Roy Kellerman, William Greer, Clint Hill (who jumped on the back of the limo as a cleanup guy after Jackie took her shot), Jackie Kennedy and additionally, Kenny O'Donnell. This team clearly was tasked to guard the casket to ensure no one found out that it was EMPTY. Jackie refused to leave the casket, however she did so under the orders of LBJ to witness his swearing in on board AF1; at that point Kellerman and Greer guarded the rear cabin door, during LBJ's swearing in, to ensure no one slipped out to look in the casket. This is the biggest reason the casket did not travel in the hold of the plane – as caskets normally do. The EMPTY casket had to be guarded at all times; they had to remove seats and break off the handles to get that casket into the plane. And these SS thugs with Jackie are all seen together in the photos when the EMPTY casket was unloaded later in Washington DC, at Andrews AFB.

The Secret Service knew questions would be asked and so they would not have entrusted the driving of the hearse to either of the funeral home's staff's, from Parkland Hospital to Love Field or from Andrews AFB to Bethesda Naval Hospital, SSA William Greer, one of the in-car shooters of President Kennedy (in addition to CIA hit lady

Because if any else lifted it or looked in it etc. there was a big risk it would be discovered empty. That's why O'Neal's staff & Gawlers did not load the casket at any time. They knew what a full & empty casket felt like...

The 2 corpses, JFK & JD Tippit (body double) were loaded onto AF2 stuffed inside a non-descript shipping casket, worked on by the CIA reconstruction expert, John Liggett, in LBJ's vacated Vice Presidential cabin. At Andrews AFB the 2 corpses were unloaded, in their unmarked casket and taken to Walter Reed Army Hospital, for the conspirators before being delivered to the rear shipping dock at Bethesda - as JFK's fancy bronze casket arrived in front...EMPTY.

Jackie Kennedy) did all of the driving of JFK's empty casket. It never made any sense until we finally took a hard look at it...why LBJ would stick around on AF1 on the tarmac at Love Field. He left Parkland at 1:26pm and waited in AF1, having instructed everyone to disembark AF2 and fly back to Washington on AF1. Officially, at that point, no one knew if there was any threat to the government. Chaos reigned supreme, was it the Russians, the Cubans, would WWII be starting? Dr. Earl Rose

is required for accountability, as transparency is always required to keep the chain of evidence clean and unassailable; in this particular case, the murder of President John F. media as having been loaded onto AF2, the conspirators fall back plan was to say that was the body of the Secret Service agent killed on the knoll. Of course, that guy should also have stayed in Texas (as should have JD Tippit) under the law just the same. Having successfully gotten JFK's (EMPTY) bronze casket flying back to Washington DC, no one would have questioned that explanation for a second, non-descript, casket being loaded onto AF2...if that had been spotted and reported by the media...but it wasn't. THE TRUTH ABOUT THE MAGIC BULLET

***Author's Note (R. Hooke):** what follows is a condensed version of **Rachel White's** original, **Complete and Detailed Analysis of Darrell C. Tomlinson's Account and the Magic Bullet** included at the end of this paper.

Shortly after JFK was pronounced dead (1pm) the **Parkland Hospital engineer, Darrell C. Tomlinson**, pushed a stretcher (gurney) back against the wall in the elevator lobby. He knocked loose a bullet which had been wedged between the mattress and frame. Tomlinson said, "I bumped the wall and a spent cartridge or bullet rolled out that apparently had been lodged under the edge of the mat." Tomlinson gave the bullet to **Parkland Chief of Security, O.P. Wright**, who gave it to **Secret Service Agent Richard Johnsen**. Tomlinson also said there were 2 rolled-up bloody sheets and some medical paraphernalia on that stretcher.

As the gravely wounded president was brought into Trauma Room 1 his blood loss was immense and the doctors did everything possible to save his life – everyone who had worked on him was covered with blood. JFK was pronounced dead at 1pm and then decisions had to be made. At that point, we believe, JFK was lifted up from his initial treatment gurney and placed onto another gurney that had a large rubber sheet already on it and other sheets to wrap him in. JFK's initial gurney was then pushed out of the room, left in the elevator lobby and was the stretcher Tomlinson pushed against the wall, because it was partially blocking the entrance to the Men's Room and a bullet fell out.

At 1:40pm, after the bronze casket had arrived from the O'Neal Funeral Home, JFK was lifted into the bronze casket on a rubber sheet that had to be fully underneath him. How does that happen unless they had another gurney? They didn't struggle to get sheets under JFK; they simply transferred him to another gurney prepared with a rubber sheet and plain sheets in order to wrap him in. This rubber sheeting is large – so attendants can lift a body hammock style and then wrap it around the body later. This rubber sheet hung over the edge, like a tablecloth, so the mattress pad, below the rubber sheet, remained clean.

“On the cart, halfway between the ear and the shoulder there was a bullet laying almost perpendicular there – but I have not seen a picture of that bullet ever since that day.”¹⁴

This means JFK’s initial gurney was up in the hospital vestibule before JFK’s bronze casket arrived at Parkland at 1:40pm. It has been said the gurney could not be JFK’s because he was still in Trauma Room 1 lying on the gurney but, as we see here, this is how that works – they had simply lifted him onto a new gurney that had a rubber sheet on top. And JFK’s initial gurney in Trauma Room 1, covered with blood and containing the bullet nurse Phyllis Hall saw, was taken away and deposited by the elevator.

The bullet found by Tomlinson and, as described by Tomlinson and O.P. I told SAC Shanklin that Secret Service had one of the bullets that struck President Kennedy and the other is lodged behind the President's car and we are arranging to get both of these. I told him to notify us when the gun will reach Washington so we can have the laboratory standing by.

with some of the President's bone, hair and brain material around it on the grass.

We contend the bullet (witnessed by nurse Phyllis Hall), that was lodged by the President's ear, was a pistol bullet fired by CIA agent Jackie Kennedy (as palm pistols fire 2 shots) into the left side of JFK's head; just like the bullet Jackie can be seen firing up through JFK's head in the Zapruder film (frame 313) that went straight up, through the left side of JFK's head and came back down in a clump of the President's bone, hair and brain material by the infield manhole cover, discovered by Sheriff Buddy Walthers, stolen away by FBI agent Robert Barret and photographed by free lance photographer Jim Murray – and that bullet, like the bullet Tomlinson gave to O.P. Wright who gave it to FBI agent Richard Johnsen, disappeared and was never seen again. The FBI's job, after J.Edgar Hoover and Clyde Tolson had signed off on JFK's execution in Dealey plaza, the evening of 11/21/63 at Clint Murchison Dallas mansion, was strickly cover up – as dictated by FBI commissioner J Edgar Hoover.

And we have an FBI memo (at the end of this paper) stating a bullet was lodged by the President's ear. CIA agent Jackie Kennedy or SSA Clint Hill must have fired another shot into JFK's head, after he was down in the car; to make absolutely certain he was dead, that lodged by his ear.

Warren Commission attorney, Arlen Specter, tried his best to confuse the issue but Tomlinson was remarkably clear about what happened that day. And, although there were 2 stretchers in the area, the stretcher that contained the bullet Tomlinson insisted was the President's stretcher and the other one was Connally's. No effort was made by the WC to determined where the stretcher came from.

Neither O.P.Wright or Agent Johnsen were interviewed by the WC because and, in later interviews with researchers, neither man could positively identify CE399 (the magic bullet) as the bullet found that day. During a 1966 interview with author Josiah Thompson, Wright – a professional security officer – picked a pointed-tipped bullet shape as having been more like the bullet he discovered at Parkland – Wright rejected the round nose bullet shapes similar to CE399. Tomlinson also selected a pointed shape as resembling the bullet he found.¹⁶

We must conclude that the round tipped CE399 bullet, that became known as 'the magic bullet' was substituted, by the Secret Service or FBI, for the initial pointed tipped bullet Tomlinson found, to provide a bullet which could be linked to the Carcano (patsy) rifle in order to frame Lee Harvey Oswald for the shooting; and, in order to coverup the fact the bullet was found on JFK's original stretcher and had fallen out of his head, where it was lodged by his ear, the conspirators floated the rumor the bullet had been

planted by Jack Ruby, whose presence, of course, at Parkland Hospital, they were unwilling to confirm.

We also must conclude, **WC attorney Arlen Specter's magic bullet theory is completely destroyed from the get go – because the actual bullet found by Darrell Tomlinson was the wrong type of bullet and could not have been fired from the patsy rifle.**

The bullet fragments recovered from Governor Connolly were of the type of the magic bullet – Carcano rifle bullets. The bullet recovered by Tomlinson was like the bullet recovered in the Presidents brain material by the manhole cover – a pistol type, pointed tipped, short range type of bullet. There would've been no pistol type bullets on Governor Connolly's stretcher and there certainly would not have been any bullets on any stretcher used by a child of a Dallas Morning News employee, as they tried to claim, who had cut his chin. We must conclude the stretcher Tomlinson recovered the pointed tipped bullet from, with 2 rolled-up bloody sheets and medical paraphenalia, was the presidents initial stretcher.

CIA Agent of Disinfo Hugh Aynesworth

The story was told, by Mrs. Ross Fuller, to The Dallas Morning News, that the bloody sheets on the stretcher found (with Tomlinson's bullet) were from her son, who was admitted to Parkland at 12:54pm on 11/22/63, for a bad cut on his chin – supposedly, as he was watching the President's parade on TV and they announced the President had been shot, he knocked over his bottle of soda pop, broke it into pieces, fell on it and started bleeding... This story sounds remarkably similar to the one told by known CIA asset/ agent of disinfo Hugh Aynesworth, who worked for The Dallas Morning News, to explain and discredit the pool of blood that was seen and photographed by the path on the grassy knoll immediately after JFK was shot. Aynesworth claimed it was not a pool of blood but a broken bottle of soda pop – when other reporters from The Dallas Morning News had photographed that pool of blood and tasted it with their finger – and definitely said it was blood. When the FBI interviewed those reporters their film was confiscated by the FBI and never returned, at which point the agent of disinfo, Aynesworth, floated his story about the soda pop. As we now know, that large pool of blood on the grassy knoll, may well have been from **Secret Service agent Chuck Robertson, the conspirator's Safety Corpse**, who disappeared on 11/22/63 and was never seen again.

And we now know it was Tony Zoppi and employees of The Dallas Morning News who provided Jack Rubenstein with his main alibi – that he was at the Dallas Morning News placing an advertisement during the shooting – when we now have discovered photos of Rubenstein in Dealey plaza managing the hit for the Deepstate.

CIA Conspirators – Compulsive, Creative and Consecutive Liars

Once the Illuminati/CIA Zionist conspirators had made up their lie, that JFK's stretcher was the Fuller child's who had cut himself, they had to create a second lie – that the bullet on the stretcher was planted – because there never would have been any bullet on the stretcher of a young child. And then, of course, the CIA Zionist conspirators took advantage of that opportunity to expand their lie, in saying their bogus planted bullet was a round-tipped Carcano rifle bullet, that matched the patsy rifle, in order to additionally frame their patsy, Lee Harvey Oswald.

And the rumor was also floated that Jack Ruby had planted that bullet – in order to avert suspicion of what Jack Ruby was really doing inside Parkland Hospital...when the true purpose was that Ruby was there to call for the delivery of JFK's back up corpse, Dallas Policeman Jefferson Davis Tippit.

And finally, we now realize, this was all to cover up for CIA assassin Jackie Kennedy, who fired a short range pistol bullet up through the left side of JFK's head, the pointed-

tipped short range pistol bullet found in the presidents brains by the infield manhole cover – just like the bullet found, by the hospital engineer Tomlinson, on JFK's initial stretcher at Parkland, that was undoubtedly a second shot, from Jackie's 2 shot Deringer, into the left side of JFK's head, that had fallen out onto that stretcher.

Jack Ruby Called for the Hit on JD Tippit

We must conclude that Jack Ruby did not plant the so-called magic bullet because no pristine Carcano type bullet (round tipped) was ever found on any stretcher at Parkland. Jack Ruby was at Parkland around 1pm but he was there mainly to assess whether or not JFK's body double would be necessary. Once Ruby got word that JFK's corpse was pretty much destroyed, as far as the conspirators having been able to claim all the damage was done by their lone-nut patsy (Oswald) from the rear, Ruby, no doubt, called the Dallas police switchboard who relayed a call to the police car (not Tippit's) that was parked in the driveway at 10th & Patton and Gary Marlow (CIA) was informed he was going to have to shoot JD Tippit because a body double was definitely needed for JFK's autopsy, ASAP, to be flown back east on AF2 and be mocked up as JFK by the CIA reconstruction expert John Melvin Liggett. The regular Dallas police switchboard operator, Margie Barnes was given the day off and tickets to JFK's Dallas Trade Mart luncheon on 11/22/63.

We must now ask ourselves – Why would Jack Ruby have planted a bullet that was obviously not of the right type for the patsy 6.5mm Mannlicher Carcano rifle? And Jack Ruby did not have time to go plant any 'magic bullet' – as it was not known at the time, Ruby was at Parkland, if any magic bullet was necessary and, besides, Jack Ruby was in a hurry to get back to the Texas Theater, in Oak Cliff, where he pointed out Lee Oswald, from behind, to the Dallas police.

STRETCHERS & SCRUB NURSES

An additional explanation, worthy of further research is the possibility that the scrub nurses, including Diana Bowron and Margaret Henchcliffe, were complicit. Margaret Henchcliffe, just like Aubrey Rike, wrote a book on the assassination and that's what these traitors do sometimes to reinforce their lies; and nurse Diana Bowron had been recently transferred from England. If a few of the nurses were involved it would help explain how the President was swapped out of his Bronze casket, undetected. It's also possible, after JFK had already been placed in the casket, when Rike and McGuire went back into Trauma Room 1 to finally retrieve it, they opened the casket, lifted JFK back out and placed him back onto his gurney, under a sheet. Then Rike and McGuire shut the casket, went through the door and wheeled the EMPTY casket (on it's folding mechanical dolly) back to the hearse with SSA Kellerman and the Presidential entourage. Then, once the commotion was gone, down the corridor, Nurse Margaret

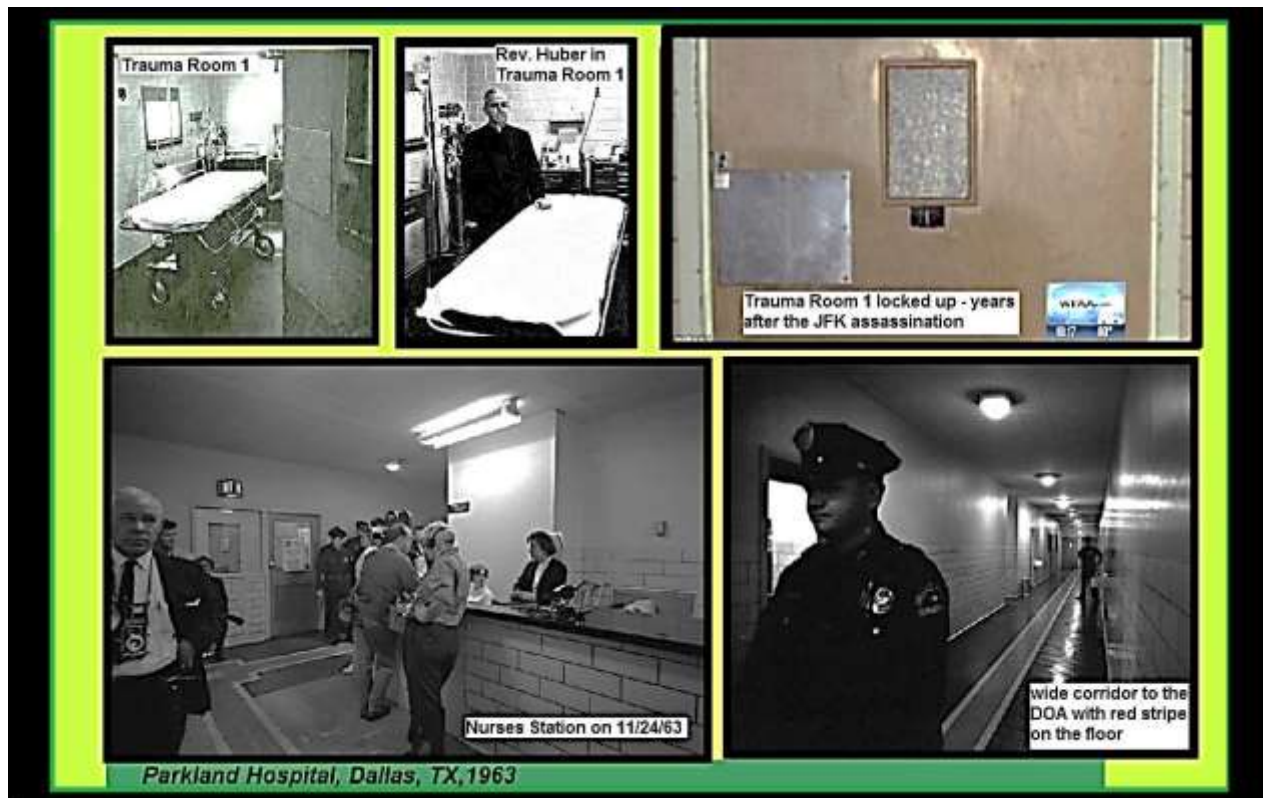

Henchcliff pushed JFK on his gurney out the door and into Trauma Room 2 – as she told us she did – but the stretcher contained JFK.

“Nurse Margaret Henchcliff testified before the WC that after the President’s body had been put in a coffin, she had pushed his stretcher across the hall into a vacant room.”¹⁸

Then she rolled another stretcher back into Trauma Room 1 and someone, when the coast was clear, pushed JFK on his stretcher (under a sheet) out, by the treatment booths and down the wide corridor to the DOA room – to meet up with JD Tippit and CIA embalmer John Liggett, shortly after 2pm. Dallas policeman JD Tippit and President John F. Kennedy were packed together, in the same unmarked casket, loaded into John Liggett’s van and driven to AF2.

Think about it...the conspirators had the O’Neal Funeral Home owner and attendants on board and they knew there were going to be moments of cleanup and preparation where only the scrub nurses would be in Trauma Room 1 with JFK’s body. The right way, of course, would’ve been to have had an armed guard in that room, guarding the President, the entire time. But did the American people get that? HELL NO.

My son (R.Hooke), who first told me Lee Oswald never shot anyone on 11/22/63 and for me to investigate, works at an Apple Computer Store and they have armed guards, with the computer equipment, all of the time – so safeguarding the accuracy of the medical examination of the President of the most powerful nation in the history of the world, after he had been gravely shot, is not worth the same?

Rod Mac Kenzie¹⁹ (aka Ward Alexander) the DISC²⁰ manager of the Holland Ave. SAFEHOUSE in 1963, where the TSBD 6th floor Hit Team conspired to shoot JFK, was also employed as a scrub nurse at Baylor Hospital, in Dallas. After the assassination, the conspirators (Mac Kenzie's DIA²¹ Handler, Jake Miranda) transferred MacKenzie to Parkland Hospital, employed as a scrub nurse, to spy and take notes on the doctors and nurses. MacKenzie said his transfer was all set up and he just reported for work the second Monday after the assassination with no interviews or anything. Surely, if it was important enough to plant a scrub nurse (MacKenzie) after the assassination – a few scrub nurses working directly on JFK were also plants, as the conspirators left nothing to chance and no doubt turned a blind eye and were also complicit. It's possible the CIA told Rike, McGuire and a couple of the scrub nurses that, for security reasons, they were going to have to take the president back east in a different box – so they had to take JFK back out of the bronze casket... and they were instructed never to disclose that to anyone.

Vernon O'Neal & Rike's Bloody Shirt

After the assassination, the funeral home owner, Vernon O'Neal, displayed Aubrey Rike's bloodied shirt (from when he attended to JFK), in a protected case, mounted on the wall of his office – a grotesque reminder of the involvement of the funeral staff that day. I can't help but feel that that shirt, hidden in plain sight, contains some forensic secrets. 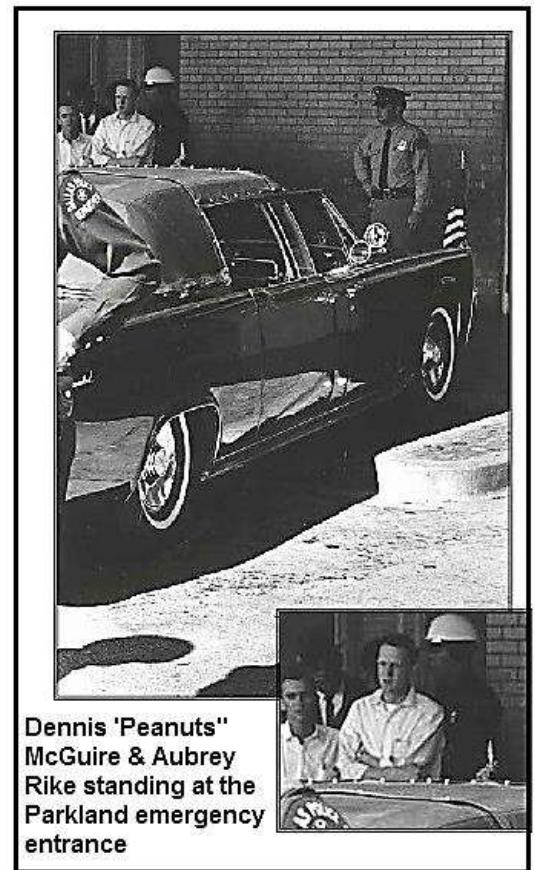
What Had Aubrey Rike Done?

Shortly after JFK was shot, Glenda Rike (Aubrey's wife) received a phone call, while she was at work in downtown Dallas. The caller identified himself as an FBI agent and said, "We have your husband. You need to keep your mouth shut, do you understand?" "Yes," Glenda said and then she heard the phone click.

I think the conspirators probably told the funeral attendants, Rike and McGuire that, for reasons of National Security, JFK was going to be transported back east in a different box and they had better not ever talk – if they knew what was good for them and their loved ones. That's why, when Rike and McGuire when out for a bite to eat, at the Waffle House on Oak Lawn Ave. at 8pm that evening, they walked out without having even taken one bite to eat...Silently they walked back across Oak Lawn Ave. to the funeral home and Peanuts went upstairs, where they normally went and Aubrey went in the casket selection room and wept uncontrollably²².

And that's also why Rike got so emotional when he was interviewed by JFK Assassination **Researcher David Lifton**, when Lifton asked Rike if he had loaded JFK into a body bag and a shipping casket at Parkland. Actually, Lifton, who seemed a bit reluctant to upset Aubrey any further, was asking the wrong question – what Lifton should have asked is, 'Aubrey, did you lift JFK back out of that bronze casket?' Because if he had, Rike may have given away the fact that was exactly what happened – which surely would indicate JFK went back east in an unmarked shipping casket to Washington DC.

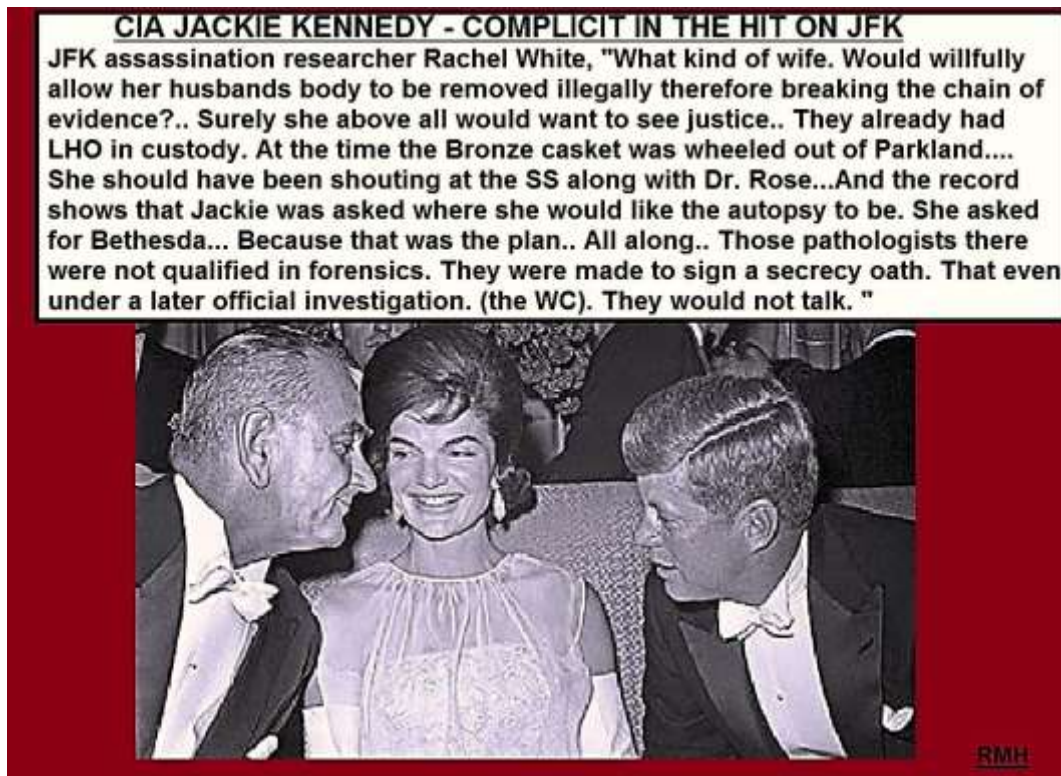

Researcher Rachel White's Complete and Detailed Analysis of Darrell C. Tomlinson's Account and the Magic Bullet:

Just after President Kennedy was pronounced dead at Parkland at 1pm, **Parkland senior engineer, Darrell C. Tomlinson**, found what was later referred to, by Arlen Specter of the WC, as the magic bullet (CE399). As with many things in this case we need to really bottom out what occurred here to see the truth of the matter. I'm not going to write about the intricacies of the magic bullet theory. What I'm going to detail out here is from another angle. Tomlinson testified to the WC that, just after 1pm, he pushed a stretcher (which has become known as stretcher A) out of the elevator into the elevator lobby. Clearly it was in his way. He made several trips up and down the elevator during his duties. At some stage after 1pm he was again in the elevator lobby where stretcher B and A both were. Stretcher B was protruding some into the entrance to the Men's room for access. Tomlinson pushed stretcher B back against the wall whereby he clearly knocked loose a bullet that had been wedged between the mattress and the frame. He found the bullet, did not mark it in any way and handed it to the **Parkland Chief of Security, O.P. Wright**, who gave the bullet to **Secret Service agent Richard Johnsen** (still present in the hospital); this puts the event occurring between 1pm and 2:20pm. We know JFK's casket was loaded into the hearse at 2:20pm and the Secret Service team left the hospital at that point.

Tomlinson testified that, just after 1pm, on stretcher B, that he had pushed against the wall, were two rolled up bloody sheets and medical paraphernalia. I want to show you how that could very possible be JFK's stretcher. As the wounded Kennedy was brought into Trauma Room 1 his blood loss was immense. Everyone treating him was covered in blood. The doctors did everything necessary to save his life. It was futile. JFK was pronounced dead at 1pm. At that point everything changed because decisions had to be made about what happened next. It was at that point, I believe JFK was lifted from the treatment gurney and placed onto another gurney that had a larger rubber sheet already on it and other sheets that they would wrap him in. Gurney number 1 was then pushed out of the room. It was Gurney number 1 that became stretcher B. Here's why: stretcher B could not have been in position very long before Tomlinson found it because it was partially blocking the entrance to the men's room and had to be moved for access. So the scenario of stretcher B, having been pushed out away from the wall and then Tomlinson pushing it back means no one else had touched it since it arrived there. In a busy hospital, the mens' room is used frequently. The stretcher had been in position minutes when Tomlinson pushed it back against the wall and the bullet fell out.

JFK was lifted into the bronze casket (and back out again) on a rubber sheet. That means the rubber sheet had to be fully underneath him. How does that happen unless you have another gurney?

Example: Have you ever tried to get a hot pie out of a tinfoil case, that you cooked it in, onto a plate without it falling apart? My trick is 2 plates. One on the top of the pie, turn it over, remove the foil, put plate number 2 on the pie so its like a pie

plate sandwich. Then turn the whole thing rightside up. Perfect pie. The point is you need 2 plates.

They did not roll JFK about trying to get sheets under him, they simply transferred him to another ready prepared gurney.

This rubber sheeting is large so the attendants can lift the body, hammock style and then wrapped it around the body later; that means that the mattress pad of the gurney itself remains relatively clean and there would be no blood stained sheets. Furthermore, it hangs over the edge like a tablecloth. If any item (like a bullet) rolls from the body it would roll out and onto the floor. At that point it can not get lodged or stuck anywhere because the mattress is completely covered.

My contention is that, on moving JFK's body from Gurney 1 (the original stretcher JFK was brought in on) they rolled him slightly and the bullet between his ear and his shoulder (as witnessed by nurse Phyllis Hall) got wedged between the mattress pad and the tube frame of Gurney 1. No one noticed. JFK was then on Gurney (stretcher) 2, as Gurney (stretcher) 1, covered with blood, was taken out of the room and placed in the vestibule partially restricting access to the Men's Room.

This means that Kennedy's original blood stained Gurney 1 was up in the vestibule before the bronze casket had arrived at Parkland. This has been overlooked before because its always been debated that neither stretcher A (Connolly's) nor B (Kennedy's original), in the vestibule, could have been Kennedy's because he was still in Trauma Room 1 lying on the gurney before the casket arrived. But, as we see here, this is how that works as they simply had lifted JFK onto gurney 2 .

The bullet was then found by Tomlinson but could not be verified later with CE399 which was a totally different bullet. There are some who believe the myth that Gurney 1 (stretcher B) was that of a toddler who cut himself. I feel that to be a fabricated story. The child's name was R. Fuller. To my knowledge this 57 year old, as he would be today, has never come forward to tell his story which would be a cutesie, innocent claim to fame. I invite him to come forward if he does have a story. Tomlinson was interviewed in his WC deposition by Arlen Specter. That was deliberate as Specter was the author of the magic bullet theory, CE399 and it was Specter who was thoroughly in place to direct the questioning of Tomlinson.

I contend that the bullet found on Gurney 1 (stretcher B – Kennedy's original) was a pistol bullet fired by Jackie Kennedy into the left side of JFK's head and that the subsequent stories we have been told regarding baby Fuller, CE399, stretcher A & stretcher B and who laid upon it have been inserted into the mix to cover the tracks of Mrs Kennedy.

JERRY BOYD BELKNAP, 1212 Ross Avenue, telephone number BL. 4-3373, advised he is presently employed on the assembly line at Capitol Refrigeration Inc., 3333 East Kiest Street, Dallas, Texas. He said he was born October 23, 1940, at Ranger, Texas.

BELKNAP advised that on November 22, 1963, he traveled from Irving to Dallas, Texas, by bus, leaving Irving, Texas, at about 11:45 AM. After arriving in Dallas, BELKNAP stated he proceeded to 100 North Houston Street, from which point he intended to watch the Presidential motorcade. He said he was standing on the west side of the street.

At approximately 12:10 PM, BELKNAP advised he felt a "fainting spell" coming on and attempted to move back away from the crowd. While in the process of moving from his position, BELKNAP said he fainted and fell to the sidewalk. Within a few minutes of fainting, BELKNAP stated an ambulance from Oneal Inc., Funeral Directors, 3206 Oak Lawn Avenue, Dallas, Texas, arrived and took him in the ambulance to Parkland Memorial Hospital. BELKNAP said he does not believe he lost consciousness.

BELKNAP stated that, shortly after the ambulance attendants carried him on the stretcher into Parkland Memorial Hospital, President KENNEDY was brought into the hospital. He advised there was much confusion at the hospital and little attention was being paid to him. He said he got a glass of water from a nurse and took his medication, which he is required to take three times daily, but had neglected to do so on this particular day. After taking this medication, BELKNAP stated he felt much better, informed the nurse of this, and walked out of the hospital without ever registering as a patient. BELKNAP advised this was around 2:00 PM and stated he then returned to the Dallas Morning News, Dallas, Texas, where he was employed working part time in the Mail Room.

Regarding the nature of his illness, BELKNAP explained that several years ago he was struck by a car and suffered a head injury. He stated since that time he has had fainting spells and is required to take medication three times daily to prevent this. He stated he does not believe his fainting spells are any type of epilepsy.

I talked to SAC Shanklin in Dallas. He said arrangements have been made with Carswell Air Force Base to fly one of our Agents up to Washington with the rifle that was recovered by the police together with the fragments of the bullet taken from Governor Connally and the cartridge cases. I told SAC Shanklin that Secret Service had one of the bullets that struck President Kennedy and the other is lodged behind the President's ear and we are arranging to get both of these. I told him to notify us when the gun will reach Washington so we can have the Laboratory standing by.

I told Shanklin that it appeared the rifle was highly important particularly as Oswald is making no admissions and leads should be set out to immediately check this rifle as well as the telescope sight. Shanklin said this was being done. I told Shanklin to also see if the police want us to make a ballistics test on the pistol which shot the police officer and if so to forward the pistol and the bullets to us for examination. I told Shanklin if the police don't want to release the pistol to us, he should find out all about it; that is, make, caliber, how many bullets were fired, etc.

Shanklin said that he realized that it was extremely important to locate and interview the co-workers of Oswald and any people that knew him in order to account for his whereabouts and actions, and he said this is being done.

I told Shanklin that President Johnson has been in touch with the Director and wants to be sure we are on top of this case and is looking to the FBI solving the case. It is, therefore, imperative that we do everything possible in this case. Shanklin understood.

Shanklin was advised that we are sending out another teletype to all offices instructing that any allegations or leads pertaining to the assassination must be run out on an urgent basis and the Bureau and Dallas, office of origin, advised.

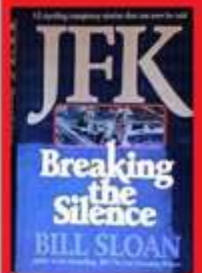
